The above Financial results for the quarter and year ended March 31, 2026 have been reviewed by the Audit Committee and thereafter approved by the Board of Directors at its meeting held on May 16, 2026. This financial results has been prepared in accordance with Companies (Indian Accounting Standard) Rules, 2015 (IND AS) notified under Section 133 of the Companies, Act 2013 and other recognized accounting practices to the extent applicable. The Statutory Auditors of the Company have issued audit report with unmodified opinion on the above results.</p> <p>2. On November 21, 2025, the Government of India notified the four Labour Codes - the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 (collectively "new Labour Codes") - consolidating 29 existing labour laws. The Ministry of Labour & Employment published draft central rules and FAQs to enable assessment of the financial impact due to changes in regulations. The Company has assessed the incremental impact of these changes on the basis of the best information available and disclosed the same in employee benefit expense.</p> <p>3. The Company is principally engaged in single segment viz. Manufacturing of wire & wire ropes based on nature of products, risks, return and internal business reporting system.</p> <p>4. Previous Year / period figures have been regrouped / reclassified wherever necessary. The figures for quarter ended March 31, are balancing figures between the audited figures of the full financial year and the limited reviewed year-to-date figures upto the third quarter of the respective financial year.</p> |
